Pecuniary Interest

Mayor Marriott requested that each member of Council declare an interest at the appropriate time within the agenda where an interest may exist.

Drains- Hodges Drain – request to replace access culvert

David Moores noted that Lee Whitton had requested to replace a second private culvert on the Hodges Drain. Mr. Whitton agreed to pay the engineering costs and construct the culvert to the specifications defined in the recent Section 78 (5) report.

Update Shepherd Drain

The Drainage Superintendent reported that while surveying in Oil Springs it had been determined that some additional land had to be added to the drainage area of the Shepherd Drain. As a result, the Court of Revision for the Shepherd Drain will need to be adjourned on April 2 2024 to permit the circulation of an updated schedule.

The Drainage Superintendent noted that recent changes had been announced that would remove the requirement for Conservation Authority approval for maintenance of municipal drains. This was based on the work being undertaken under the accepted practices for maintaining municipal drains.

The Drainage Superintendent reported on a meeting held with Enbridge to discuss municipal work that takes place near Enbridge pipelines. The Drainage Superintendent reported that work was underway on the Stewart Drain. Enbridge was engaged regarding crossing a high-pressure storage pipeline on Mandaumin Road.

The Drainage Superintendent reported that the cleaning and brushing of the Durham Creek Drain had been completed. He noted that three low level crossings would need to be lowered.

C. Road-Road Speed Sign

Mike Cumming discussed the purchase of a trailer to be used to attach the road speed sign. A discussion took place regarding the purchase of a second road speed sign.

The Road Superintendent noted that sheet piling had been installed at the intersection of Shiloh Line and Wanstead Road. The piling was to stabilize the road due to the deterioration of the culvert at that location.

The Road Superintendent reported that he was in touch with the gravel supplier to arrange the start of the delivery of maintenance gravel.

The Road Superintendent noted that he was awaiting comments from the engineering firm regarding the maintenance of the bridges at Black Ash Road and Durham Creek and Marthaville Road and Black Creek.
